Salary Increase Tip

Did you know that the time to get your biggest raise is **before** you start a job? Indeed, your negotiating position is often the strongest right after the prospective employer offers you a job. Call me if you've been offered a job, or are in job negotiations, for assistance in securing a higher starting salary and greater benefits than you thought possible.

Unemployment Compensation Law Tip

Resigning can hurt your chances of collecting unemployment benefits. Instead, make your employer fire you. This way, to deny you unemployment benefits the employer will have to prove willful misconduct on your part! Definitely call me when faced with this circumstance.

Family and Medical Leave Law Tip

You may have the right to a leave of absence from work to care for a family member in need. To assert your rights under the federal Family and Medical Leave Act ("FMLA"), let your employer know as early as possible when your health, or the health of a loved one, may require you to take time off from work. The FMLA applies to companies with 50 or more employees and as soon as you advise your employer of the situation, your employer is obligated to give you information about your FMLA rights.

Discrimination & Pregnancy Law Tip

If you believe you are being treated differently than a co-worker, and that it's because of your age, race, national origin, pregnancy, gender, religion or disability, it's important that you be able to justify your belief with facts. Maintain a log at your home which records all the instances wherein your colleagues were treated better or differently. This log can be very important later in proving a case discrimination. Just jot down the facts of what occurred - who was treated better and differently, and how.

Overtime Pay Tip

If you are a worker paid by the hour you may be entitled to higher pay for every hour you work beyond 40 each week. The Fair Labor Standards Act can protect employees like you and if you believe you are eligible for overtime pay I urge you to contact me.
